TUITION AGREEMENT

Tuition Rates and fees effective January 1st, 2022

Tuition Payment

Tuition is paid in full in advance on Monday or the first day of your child's week, regardless of absences or holidays. **No refunds are given for absences or holidays.**

Late Payment Fee	\$ 10.00 per week over 10 days late
Returned Payment Fee	\$ 20.00 per payment returned

Late Pickup Fee

A late pickup fee of \$5.00 for first 5 minutes or fraction thereof and \$1.00/min thereafter will be due per child if the child is at the center later than their departure time or the closing time of the center (5:30 p.m.).

Full Day and Half Day

A **full day** is considered any time from 7:00 a.m. to 5:30 p.m. A **half day** is considered any time from 7:00 a.m. to 12:00 p.m. OR from 12:30 p.m. to 5:30 p.m.

Family Discount

A discount of 10% off the tuition rate is offered on the 2nd child when two or more children are registered at the same time.

Vacation Week

Each family has a one-week tuition-free vacation per calendar year based on the weekly schedule contracted below. We request a two-week notice of your scheduled vacation time.

Termination

A two-week written notice is required for termination or changes made to this Tuition Agreement.

Contracted Hours

Children are enrolled for a specific time period so that we can provide appropriate staff to child ratios. Upon registration, the following days and hours will be in effect for your child unless and until we are notified of changes.
