Tuition Rates and fees effective February 3rd, 2025

Tuition Payment

Tuition is paid in full in advance on Monday or the first day of your child's week, regardless of absences or holidays. No refunds are given for absences or holidays.

Late Payment Fee Returned Payment Fee \$ 10.00 per week over 10 days late \$ 20.00 per payment returned

Late Pickup Fee

A late pickup fee of \$5.00 for first 5 minutes or fraction thereof and \$1.00/min thereafter will be due per child if the child is at the center later than their departure time or the closing time of the center (5:30 p.m.).

Vacation Week

Termination

A two-week written notice is required for termination or changes made to this Tuition Agreement.
